Your KW Website powered by Placester is the newest website provided to KW agents and is mobile responsive, SEO friendly, and has IDX and blogging capabilities built in.

Find the KW Website

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”
3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
 - a. If this button is not available, your site needs to be activated. In order to activate this site, please ask your MCA to add your MLS ID to the KW Whitepages. We would do this for you, or include instructions for how to do it yourself, but unfortunately only MCAs have that capability. Within 48 hours after they add it, you will receive a notification to your KW email, and a pop up notification when you log in to mykw, that the site is available. Once you receive that notification, just complete this form and we'll get it all set up:

Site Settings

Listings

Check/Setup IDX Integration

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”
3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”

6. On the left, under “Listings”, click “IDX Integration”
 - a. By default, the KWLS (KW Listings Only) will be selected
7. If your local MLS is listed, click “Use This MLS” to the right
8. If your local MLS is NOT listed, check with your office to get the IDX setup process for this site started
9. At the bottom right, click the green “Save” button

What is IDX?

IDX stands for Internet Data eXchange, which is the way that the MLS sends listing data to the agent's websites. Each KW agent should have three (3) IDX connections set up:

- Wolfnet/eAgentC for the KW App. This enables app users to search the full MLS, not just KW listings, and enables agents to see who has created an account and saved properties.
 - Log in to mykw.kw.com
 - In the eEdge Control Panel, click the Plus Sign (+) next to “My Marketing”
 - Click “Manage eAgentC Website”
 - On the left, click section 4.0
 - Click section 4.1
 - Check the box under the dropdown
 - Click “Sign Up”
 - If you don’t have the checkbox, ask your MCA to add your MLS ID to the KW Whitepages, then wait 15 minutes and follow these instructions.
 - Additional steps may be required, such as paperwork. Contact your Market Center Leadership for more information.
- Marketleader/eEdge. Allows eEdge site visitors to search the full MLS, and enables agents to create listing alerts and "listing-enabled" marketing materials within eEdge
- Placester/KW Website. Enables site visitors to search the full MLS.

Global Filters

On this page, you can choose which listings visitors to your site can find. I.e. Only commercial, only residential, only for sale versus for rent, only a certain price range, only certain zip codes or cities. Note that these settings will limit what listings can be found anywhere on your site, so it would be unwise to make these settings too narrow (i.e. only your listings, or only your office's listings)

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over "Technology"
3. Click "KW Websites"
4. Click the red "Go to my website" button in the center of the page
5. On the left, click "Edit Site"
6. On the left, under "Listings", click "Global Filters"
7. Choose what areas/criteria you want to limit your listings to
 - a. i.e. city, zip code, min/max beds, min/max price, agent ID
 - b. To add a new search criteria, click the "Add Search Criteria" dropdown, and select the criteria, then click "Add" to the right
8. Click "Search"
 - a. A preview of which listings would show will list underneath
9. At the bottom, click the green "Save " button

Featured Listings

This section is where you choose which listings will display on the home page of your site, below the search bar or on a created featured listings page. Depending on the theme selected, anywhere from 4 to 16 listings will display on the home page, but all listings will display on the created page.

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over "Technology"
3. Click "KW Websites"
4. Click the red "Go to my website" button in the center of the page
5. On the left, click "Edit Site"
6. On the left, under "Listings", click "Featured Listings"
7. Choose what areas/criteria you want to limit your listings to
 - a. i.e. city, zip code, min/max beds, min/max price, agent ID
8. To add a new search criteria, click the "Add Search Criteria" dropdown, and select the criteria, then click "Add" to the right

9. Click “Search”
10. A preview of which listings would show will list underneath
11. At the bottom, click the green “Save “ button

Open House Info

Site Design

Theme Selection

This section allows you to change the look and feel, and some coloring, on your site. NOTE: Do NOT choose a theme based on the picture displayed in the preview behind the search bar. The pictures on that slideshow can be changed at will. Choose your theme based on layout and coloring, instead.

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”
3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. On the left, under “Site Design”, click “Theme Selection
7. Use the arrow buttons to the right and left of the preview to scroll through the theme options
8. Once you have a theme you like, some allow you to choose a color scheme, below the preview
9. On the “Madison” and “Madison Metro” themes, you can choose for the header to be filled with the color chosen, with white text, or filled with white, with text in the color chosen.
10. On some themes, you can set a message to display over the slideshow, above the search bar
 - a. Up to 60 characters (including spaces)
11. At the bottom, click the green “Save” button

Slideshow

The slideshow displays behind the search bar on your home page. Your slideshow images are fully adjustable. Each theme allows up to 5 scrolling slideshow images. Please visit this help article for image resizing tips and to learn ideal slideshow dimensions for each Placester theme:

6. On the left, under “Site Design”, click “Slideshow”
7. Click “Select” on the preset template you would like to use, or click the Plus sign (+) at the top left to create your own
 - a. You can change the images contained within a preset template which will create a new slideshow
 - b. Click the “Upload” button to upload a new image
 - c. You can add a caption for each image, if you like
 - i. Note that the caption will display in white text at the bottom left of the picture. There is no way to change the size or color of the caption, so it would help if your picture had a dark area near the bottom left
 - d. You can paste in a link for each image, which will go to that link when the image is clicked
 - i. I.e. for a specific listing, upload the listing image, then find the listing on your site, and paste that link in the “Link” box so that if that image is clicked, it will go directly to that listing’s page
 - e. At the bottom, click the green “Save” button to save the slideshow itself
8. At the bottom, click the green “Save” button to save which slideshow is selected

3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. On the left, under “Site Design”, click “Certifications”
7. Click on the Certification(s) you would like to display
 - a. Up to 6
8. At the bottom, click the green “Save” button

Social Media

2. In the top black menu bar, hover over “Technology”

5. On the left, click “Edit Site”
6. On the left, under “Site Design”, click “Social Networks”
7. Type in the ending of your social media profile url as requested
 - a. i.e. facebook.com/scottleroymarketing would just be “scottleroymarketing” for the Facebook section
 - b. On LinkedIn, be sure to add “in/” before the rest of your linkedin URL. This is necessary, but not noted on the page. i.e. linkedin.com/in/scottleroymarketing would be “in/scottleroymarketing”
8. At the bottom, click the green “Save” button

Search Form

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”

3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. On the left, under “Site Design”, click “Search Form”
 - a. Depending on the theme, several search form options will be available
7. The “Omnibox With Autosuggest” is a KW-exclusive feature, and allows visitors to search the entire listing using regular expressions, rather than dropdown options
 - a. i.e. “3 bedroom 2 bathroom austin, tx fence pool 1500 square feet” in the box, rather than selection different dropdowns for each piece
8. At the bottom, click the green “Next” button
9. Depending on the search box selected, additional items to add/remove may be available
10. At the bottom, click the green “Save” button

Menu

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”
3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. On the left, under “Site Design”, click “Menu”
7. To rearrange menu items, click and drag them into the order you want
8. To create a “sub menu” drop down, hold one menu item on top of the other then release
 - a. It will then be indented below the main menu item
9. To add a new button, click the dropdown labeled “Home” under all of the menu options
10. Click the name of the previously created page to add, or “Custom URL”
11. Click “Add”

12. At the bottom, click the green “Save” button

7. Site info fields:

- a. Brand Name: Displays near the top left of the site, next to the site logo
- b. Tagline: AKA slogan/catchphrase, displays below the Brand Name
- c. Logo: You can add a new logo or choose from existing Placester logos in the system (note not all Market Centers have a logo within Placester
 - i. If your office/MLS requires your office's logo to show on the site, this is where to upload it
- d. Site Header: Choose whether or not to display the above 3 fields
- e. Upload Favicon: upload the icon that displays in the browser bar at the very, very top
 - i. Square
 - ii. Simple is best (i.e. just a letter or two, or recognizable symbol/logo)
- f. Name: Your name to display on the home page
- g. Email: The email address that a new message will be composed to when "Email Me" is clicked on the home page (Can only be in the "Email Me" text, cannot display plain text of your email address, or change to say "Email Us")
 - i. When "Email Me" is clicked, it will open THAT computer's default email program, cannot be specified within the site
- h. Phone: Displayed next to "Email Me"
 - i. On mobile devices, will call that number when tapped
 - ii. If multiple numbers are entered, an error will occur when tapped (it will try to dial both numbers as one long number)
- i. Photo: Upload your picture
 - i. On the site, if the top of your head seems cut off, upload a picture with more space above your head
- j. Company: Your office name
- k. Email: Your office email
- l. Phone: Your office phone
- m. Address: Your office address
- n. City: Your office city
- o. State: Your office state

- p. Zip: Your Office Zip
 - q. Meta Title: The blue title displayed on search engines when you are found in search results
 - r. Meta Description: The gray text displayed below the blue title on search results
 - i. This is not the place to load up tags (i.e. homes for sale houston, houston real estate, houston houses, houston). This is read by actual people when you display in search results, and should be a helpful description of what will be found on the site
8. At the bottom, click the green “Save” button

Lead Capture

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”
3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. On the left, under “More” click “Lead Capture”
7. Select Passive or Aggressive for the Lead Capture options
 - a. Passive: Visitors can view all listings without submitting contact information
 - b. Aggressive: Visitors must submit contact information before viewing any listings
 - c. For additional lead capture options (i.e. only require information after X listings) contact Placester directly to upgrade
8. In the “Lead Forwarding” section, enter any emails you want to be notified of a new lead coming in to your Placester site, separated by commas
 - a. Make sure to include your eEdge “@kwrealty.com” address, so that leads from this site will automatically be added to your eEdge database ([See Update Information That Auto-populates on Marketing Material](#) to find this address)
9. At the bottom, click the green “Save” button

Custom Domain

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”

3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. On the left, under “More” click “Custom Domain”
7. To edit your “.kw.com” site address:
 - a. Click “Edit” next to the existing address
 - b. Type what you want before the “.kw.com” section
 - c. Click “Check Availability”
 - d. If the domain is available, click the green “Save” button
8. To add a custom domain that you have already purchased:
 - a. In the “Add a custom domain” box, enter the full address of your site, including “www.”
 - i. i.e. “www.scottleroymarketing.com” rather than just “scottleroymarketing.com”
 - b. Click “Add Domain”
 - c. Click the “step-by-step help articles” link on the right for step by step instructions on how to configure your domain at your domain registrar to properly connect to your site

Site Tracking

In this section, you can connect to tracking services to track site visitors’ activity (not contact information) on your site. I.e. where they came from (search engine, typed the address, email link), how long they were there, which pages they looked at, etc for Google Analytics, Google Adwords, and Facebook business.

1. Tracking ID: The Tracking ID provided by Google Analytics
 - a. In the format “UA-#####-01”
2. Conversion ID: Provided by Google Adwords
3. Conversion Label: Set within Google Adwords

4. Facebook Pixel ID: Provided by Facebook Business
5. For more information on each of these services, contact the providers directly or visit www.SLMTips.com

Site Verification

In this section, you can add the required information to verify that you actually own this site for Google Webmaster Tools, Bing Webmaster Tools, Pinterest Business, and Google Plus.

Pages

Pages are static areas of your site that will not be updated frequently, and do not provide information that is shown in a blog post, agent page, testimonial, or area. I.e. Buyer/Seller Resources, your preferred vendors, recently closed listings, etc

Create a Custom Page

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”
3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. At the top, next to “Site Settings”, click “Pages”
7. Click the Plus Sign (+)
8. In the “Template” dropdown, choose what kind of page you are creating:
 - a. Default Page Template: Simple page where you can add your own content without any special formatting
 - b. About Page: Should already exist. Add your bio/experience, etc
 - c. Agents Index: Lists all of the agents that have a page created under “Agents” (see “Agents” section)
 - d. Areas Index: Lists all of the service areas that have a page created under “Areas” (see “Areas” section)
 - e. Blog Post Index: Should already exist. Lists all of the blog pages that have been created under “Blog” (see “Blog” section)

- f. Client Profile: Should already exist. Displays favorited properties for site users who have created an account and favorited properties
 - g. Contact Page: Should already exist. Contains the contact form. Additional information to be displayed below the contact form can be added under “Page Content”
 - h. Custom Landing Page: Not available through KW subscription. Contact Placester directly to upgrade
 - i. Featured Listings Page: Shows all listings that meet “Featured Listings” criteria, not limited to however many the theme shows on the home page
 - j. RSS Feed Index: Lists blog posts from another site (i.e. your existing blogspot or activerain site)
 - i. Requires an RSS feed URL
 - k. RealSatisfied Ratings and Reviews: Lists testimonials from RealSatisfied
 - i. Requires setup/login to RealSatisfied
 - l. Testimonials Index: Lists all testimonials added under “Testimonials” (see “Testimonials” section)
9. Add your page content (if applicable)
- a. Supports some HTML options, video, images, etc
10. Display Full Width: Choose whether or not you want the agent contact form to display to the right of the page content
11. Add this page to my menu: Choose whether or not you want a link to this page added to the end of your menu
12. Meta Title: The blue title displayed on search engines when this page is found in search results
13. Meta Description: The gray text displayed below the blue title on search results
- a. This is not the place to load up tags (i.e. homes for sale houston, houston real estate, houston houses, houston). This is read by actual people when this page displays in search results, and should be a helpful description of what will be found on the page
14. Click “Save as Draft” if you don’t want this page public yet
15. Click “Save” to publish the page

5. On the left, click “Edit Site”
6. At the top, next to “Site Settings”, click “Blog Posts”
7. Click the Plus Sign (+)
8. Give your blog post a title
 - a. Shows on the “Blog Index” page before opening the post
9. Add your content
 - a. Minimum 300 words

10. Optional: Excerpt
 - a. Small portion or summary of the text that will display on the “Blog Index” page before opening the post
11. Optional: Featured Image
 - a. Main image that will display on the “Blog Index” page next to the title before opening the post
 - b. If the post is shared on social media, this will be the image
12. Meta Title: The blue title displayed on search engines when this page is found in search results
13. Meta Description: The gray text displayed below the blue title on search results
 - a. This is not the place to load up tags (i.e. homes for sale houston, houston real estate, houston houses, houston). This is read by actual people when this page displays in search results, and should be a helpful description of what will be found on the page
14. Click “Save as Draft” to not make this post public
15. Click “Publish” to make this post public

Edit an Existing Blog Post

1. Log in to myKW.kw.com
2. In the top black menu bar, hover over “Technology”
3. Click “KW Websites”
4. Click the red “Go to my website” button in the center of the page
5. On the left, click “Edit Site”
6. At the top, next to “Site Settings”, click “Blog Posts”
7. Click on the name of the post, or on “Edit” in the 4th column
8. Make your changes

KW Website Powered By Placester F.A.Q.

- My KW Website is not yet available on my account, but I want to know the address to use on marketing materials. What will my site address be?
 - By default, your KW Website address is supposed to be the same as your KW email address, but replacing the “@” symbol with a “.”. I.e. scottleroy@kw.com becomes scottleroy.kw.com
 - NOTE: For Associates in Canada, the site address will end in “.kellerwilliamsrealty.ca” rather than “.kw.com”
 - NOTE: We make no guarantees as to what your site address will be, as we have seen some cases where the site address assigned by default did NOT follow these conventions
 - Dots, dashes, or underscores in the KW email are exceptions:
 - scott.leroy@kw.com becomes scott-leroy.kw.com
 - scott-leroy@kw.com becomes scott-leroy.kw.com
 - scott_leroy@kw.com becomes scott-leroy.kw.com
 - Note that you can follow the instructions in the “Custom Domain” section to edit the part before “.kw.com”, and these guidelines would not apply
- Why does nothing happen when I click the “Email Me” link on my KW Website?
 - The “Email Me” link will open the default mail program set on each computer that visits the site. If a default mail program has not been set, nothing will happen
- Why does Outlook/Mac Mail/Thunderbird/etc. open when I click the “Email Me” link on my KW Website?
 - See above. This behavior will be different for each and every computer, depending on what the default mail program has been set as
- Is it possible to show my listings on the home page, but then my office’s listings if I don’t have any?
 - Unfortunately no, that is not a possibility at this time. The featured listings section can show *either* your listings *or* your office’s listings
- Why does my “Featured Listings” section show listings from [Insert City Here] which is very far from my actual service area?
 - By default, the “Featured Listings” section will display the highest-priced listings in your entire MLS, which are often in bigger cities. Edit your featured listings filters to update this.

- If the KWLS is selected as the MLS under “IDX Integration”, it will show the highest listings in the KWLS, which are usually in larger metropolitan areas
- Can I forward my KW Website powered by Placester to another site?
 - Absolutely! Simply add the domain of the other site as the custom domain in the “Custom Domain” section, but don’t complete the steps for changing the DNS settings for the domain. This way, when someone types your “_____.kw.com” address into the address bar, it will redirect over to whatever other site you entered
- Can I add a Facebook/Blog/Twitter/Activerain/etc. widget to my site home page?
 - Unfortunately no. The templates provided by placester are the only way to make changes to the layout/look of the home page
- How do I create a “Landing” or “Squeeze” page on my site?
 - There is no option for a page that only has the option to collect contact information in exchange for something you provide to the visitor (like a home valuation or neighborhood guide) before allowing the visitor to do anything else, without contacting Placester to upgrade. However we have some services available to use Google Forms to accomplish much the same thing. Send us an email at Support@ScottLeRoyMarketing.com for more information
- Why does “Not secure” show in the address bar for my site? How can I make this go away?
 - This notification only serves as a reminder not to enter any sensitive information, such as credit card or social security numbers, into the site. As of 2017-11-17, there is no way to remove this notification. Direct further inquiries to support-kw@placester.com.

KW Email

Your KW email is powered by Google's GSuite for Business, and behaves nearly exactly the same as any other Google account. This email is not accessed through mykw.kw.com, but rather directly through Gmail.com just like any other GSuite account. You can add this email address to your phone, set up filters, forward it to another address, etc. exactly as you would with another Google account.

KW Email F.A.Q.

- Can I use my KW Email on my phone?
 - Yes! Your KW email will work on most iOS and Android devices. Add your KW email the same way you would add any other Google account, through your device’s settings, or use the Gmail app to automatically bring over your saved signature
- Why do we have two email addresses?
 - Your @kw.com email address is your primary email and should be used for all of your accounts/marketing/communication. The @kwrealty.com address is simply the address that your marketing campaigns come *from*. If your settings are correct, any response to your marketing campaign emails will automatically be forwarded to your KW email, or whatever other email you use for your business
 - See “[Update Information That Auto-Populates on Marketing Materials](#)” for more information
- Are we obligated to use our KW email?
 - Not at all. You are welcome to use this email address if you would like to as it is a part of the Keller Williams technology fees. Since it is linked up to the Gmail platform, it will run the exact same as if you were to utilize a @gmail.com account.
- Why do some Google services not work using my KW email?
 - Almost all Google services can be used through your KW email. The full list can be found here: http://answers.kw.com/customer/en/portal/articles/2822714-google-apps-connected-to-the-kw-g-suite?b_id=1286
 - Note that some of the Google apps not accessible through your KW email have to do with money: Adwords, Adsense, Wallet, Play Store, etc. This is because if you leave KW, Google has no way of collecting/paying any outstanding balance.
- Do I receive any extra features with this account?
 - Yes. You receive most of the Google Apps that you would normally receive with a Gmail account (Drive, Docs, Calendar, Voice, etc), along with 30 GB of online storage instead of the normal 15 GB.
- Will I keep the same KW Email address if I transfer to another KW office? What if that office is in another state?
 - Your KW Email address goes with you no matter where you move within the company. Moving offices, changing positions, joining or leaving a team, etc.
- If I leave KW, will I still be able to access my KW email?
 - Your KW Email will remain active for 60 days (not business days) after you are removed from the KW system. You will have that time to save/forward any messages you need, and transfer contacts.

myTransactions (DotLoop)

Dotloop (eTransactions/myTransactions) is the paperless contract-to-close transaction system provided by KW International to KW Associates. This system is how you will fill contracts, have clients sign, and submit paperwork for compliance review to your office. For support in this system, contact Dotloop at 513-257-0558.

Note that in order to submit a loop to a Greensheet (see “Submit Loop To A Greensheet”), you must also be signed in to mykw.
- Can I access dotloop on my mobile device?
 - Absolutely! The iOS and Android Dotloop apps can do everything the desktop version can do, including, in the iOS app, scanning documents in using the device’s camera. Just visit your app store and search “dotloop” to download, and log in with your email address and password.

Keller Williams APP

Your Keller Williams app is a convenient way for your clients to search for properties, save their favorites, sign up for listing alerts, and contact you. One big note: There is no “agent version” of the app, nor an “agent account” within the app. There is only a client version, that both you and your client install on your phones. Any changes made to the KW App are done through mykw.kw.com, not through logging into your app directly on your phone. You do not have an account within your app by default, you will need to create one, and it will be a client account.

- The email address displayed on this form is the address that the message sent to the agent will come *from*, and is the default email address on your phone. This email address will be the personal email address of whoever is using the APP to contact the agent
- Why isn't my listing showing on the KW APP?
 - Most likely, it just hasn't syndicated through yet, which can take up to 72 hours after it is entered into the MLS
 - Another reason may be that the IDX Connection to your APP hasn't yet been set up. See "[What Is IDX?](#)" under "KW Website Powered By Placester"
 - Lastly, contact KW International support at (512) 306-7191
- Can I change my KW APP code/URL to something more user-friendly?
 - This used to be a feature for Wolfnet Pro users, but it has been discontinued
- My app is branded to another KW Agent. How do I re-brand the app with my information?
 - From the APP home page, open the menu
 - Tap "My Account"
 - At the bottom, tap "Agent Search"
 - Follow the steps in "[Brand Your KW APP](#)"
- I transferred KW Offices, and my app still displays the old office's city at the bottom. How do I update this?
 - When transferring KW Offices, an agent gets a new app in the new office. To re-brand the app with the correct office information, follow the same steps shown above for re-branding the app from another agent.

myContacts

myContacts, powered by eEdge, is the KW Agent's "database". This is where agents will enter everyone they know or interact with, to be able to follow up with them, record notes, and send them listing alerts or campaign emails. A few notes:

- A maximum of 15,000 contacts are allowed in the basic eEdge database
- A maximum of 5,000 messages per month are allowed to be sent in the basic eEdge database
- Importing contacts who have not opted in to receive emails from you is strictly prohibited and could result in deactivation of your account
 - I.e. from Facebook, which is impossible as of August 2017. Facebook has prevented any kind of export of your friends list in order protect users from receiving emails that they never signed up for, even if they have already connected with you.

An accurate phone number and email address is all that is really needed.

2. Agent Website Admin – This takes you to the editor for the retired eAgentC Website, now only used to update the information shown on the KW APP. See “[Update Your Information Displayed On The KW APP](#)”
3. KW Commercial – Provides information about KW’s commercial division.
4. KW GPS – This page is only available to agents who are part of the Global Property Specialist division.
5. KW Luxury Homes – Provides information about KW’s luxury division.
6. Farm and Ranch – Provides information about KW’s farm and ranch division.
7. KW Worldwide – Provides information about KW’s worldwide division.
8. Mega Agent Expansion – Provides information on how mega agent teams can expand and grow.
9. KW Young Professionals – Provides information about the Keller Williams Young Professionals Division, which prepares the future leaders of Keller Williams to carry forth our company mission while preserving and strengthening our unique culture.

Education

1. KWConnect – This is the central location for all of KW’s educational information, including webinars, class manuals, and more.
2. Keller Williams University – Redirects you to the KWU Connect home page.

3. KWU Faculty – Provides resources for individuals who teach KWU courses, such as Ignite, Win with Sellers, Win with Buyers, etc.

At Family Reunion 2018 the new Referrals section of KWConnect.com was unveiled to KW Associates as a simple means to send and receive referrals to other KW Associates. Associates can search for and add other associates to their referral network according to sales units, geographic area, and more.

Accessing the Referrals system

1. Log in to mykw.kw.com
2. In the top, black menu, hover over “Education”
3. Click “KWConnect”
4. In the new KW Connect window, click “My Referrals” in the top menu.

Sending a Referral

1. In the “My Referrals” interface, click either of the red “Send Referral” or “Grow My Network” buttons
2. At this point:
 - a. Click on the area on the map you’d like to find a referral
 - b. Search by city or zip code at the top left
 - c. Search by name at the top right
 - d. You can filter by production or certifications using the “Filter” button at the top left
3. Once one of those methods show search results, you can sort by name or units
4. When an associate catches your eye to send a referral to, at the top right of their result box you can:
 - a. Add this person to your referral network
 - b. Send them a referral immediately
 - c. With the down arrow, call or email them

Kelle Artificial Intelligence System

Kelle is an Artificial Intelligence (AI) personal digital assistant developed by KW for KW Associates, similar to Siri, Alexa, Cortana, or Google Assistant. Kelle's aim is to automate as much of your business as possible, especially keeping up with contacts in the Keller Command system. Kelle and Keller Command are still in development, and this guide will be updated as new features are released.

Downloading the Kelle app

1. Open your mobile device's app store
2. Search for "Keller Williams Kelle"
3. Download and install the app
4. Open the app and allow notifications
5. Log in using your mykw username and password

Career Growth Initiative (CGI)

The Career Growth Initiative was introduced in Summer 2015 as an extension of the Growth Initiative that Team Leaders have been using since 2011, as a way to help KW Associates set goals, break those goals down into actionable steps, and keep track of those actions. The CGI is accessed through KWConnect.com, which Associates are automatically signed in to if they are signed in to mykw.kw.com

Setting your CGI Goals

Your Market Center should have either CGI classes or a way to set a meeting with the Agent Services Coordinator (ASC) or similar role to help you set your CGI goals. This can only be done with a class code generated by your Market Center leadership, which automatically changes every 24 hours (so a class code that works one day, won't work the next day). To prepare for setting your CGI goals, think about the following:

- Where do you want to be this time next year? In two years? Five years? Ten?
 - Professionally, personally, spiritually, financially, location, etc
 - Write this down
- How much income would accomplish all of those things for you?
 - Post-tax, post-commission split, post-expenses
 - Cash in the bank to spend on your life
 - Bills, groceries, mortgage, kids, cars, activities, gifts, travel, etc
- What are your business expenses?
 - Monthly and yearly
 - Commission split to cap
 - Office fees
 - Office rent
 - Phone
 - Mileage
 - Admin/assistant
 - Marketing
 - Website
 - Car insurance

- Printing (flyers, business cards, etc)
- Association dues
- Travel
- Continuing education
- Licensing fees
- How much time do you have to dedicate to your Real Estate Career?
 - Full Time
 - Part time after a day job
 - Part time, transitioning to full time away from day job
 - Free time/for fun
 - Side job/investment properties/flipping

With those in mind, your Market Center leadership will walk you through the CGI Calculator, found on <http://kwconnect.com/page/cgi> (make sure you're logged in to mykw.kw.com so you can be automatically logged in to kwconnect.com as well) then on the "View Full CGI Calculator" button. Alternatively, to go directly to the calculator, go to <http://cgi.kw.com>. Below are the fields on the calculator, which are explained in detail on the calculator page:

- Profit (That after-tax/expenses/commission split income number)
- Tax % (Your estimated yearly taxes)
 - <https://www.irs.com/articles/how-determine-your-income-tax-bracket>
 - <https://www.irs.com/articles/2016-federal-tax-rates-personal-exemptions-and-standard-deductions>
- Royalty Cap (\$3,000 for all KW associates)
- Company Dollar Cap (Set by your Market Center)
- Monthly Expenses (For your business, see the above list)
- Additional Means (Do you make additional income through your Real Estate business, maybe as an Admin for a team)
- Commission % (Average commission percent for your half of a closed deal)
 - If you are a brand new associate, leave the default
- Avg Home Price (For homes that you've sold)
 - If you are a brand new associate, check with your Market Center for the average closing price for the office
- Seller focus % (What percent of your business do you want to be sellers versus buyers, since sellers have better ROI as outlined in "The Millionaire Real Estate Agent")
 - If you are a buyer agent, just flip that in your head to "Buyer" focus
- % Conversion Rate (Listings taken to listings closed)

- If you are a brand new associate, 50% is a good starting point
- If you are a buyer agent, flip that in your head to “Broker agreements signed to closings”
- % Conversion Rate (Listing appointments to listings taken)
 - If you are a brand new associate, 50% is a good starting point
 - If you are a buyer agent, flip that in your head to “Buyer appointments to broker agreements signed”

The calculator will use your numbers to calculate your Total Gross Commission needed for the year/month, and then break that down into total number of closings needed (seller and buyer) needed for the year/month, and then break that down into total number of Listings taken needed for the year/month, then down into Total Listing Appointments needed for the year/month. You will be surprised how quickly a Total Gross Commission of \$200,000 or more breaks down into just 6 or 8 listing appointments per month, depending on your conversion rates.

Using the CGI tools

Once your goals have been set, you are able to update them any time by going to the calculator using the same steps mentioned before, then clicking “Set My Goal”, if you find that your expenses, conversion rates, or even your goals are different than you had initially expected.

Also found on the CGI page on KWConnect is the CGI tracker where you enter your listing appointments as you have them. Your actual listings taken, closings, and gross commission amounts will automatically go in each month.

Below that are tools to help you organize your goals, practice the steps to get those appointments, and track your appointment and production numbers. We won't go into much detail here because there are individual videos for how to use each tool on the CGI page.

KW Reports

The reports section is full of useful information about your production and activities within KW, from your year-over-year production to how many people have downloaded your KW App.

App Download Ranking

1. Log in to mykw.kw.com
2. Near the top left, next to your picture, click “Reports”
3. Hover over “Reports”
4. Hover over “Rankings”
5. Click “Agent Mobile Downloads”

This report will show a ranking of all KW Associates by how many people have installed their KW App. Your number and rank will be displayed above the list.

Please note that this report will not show you **who** has downloaded your app. To see information on who has created an account/saved properties in your app, see [“See Who Has Created an Account/Saved Properties in your KW App”](#)

eEdge myEmail (Legacy)

eEdge email is handy for sending messages to multiple contacts within your database, but should not be your primary email used for sending and receiving messages on a daily basis. See instead the “KW Email” section.

Notes:

- A maximum of 2,000 messages may be sent from within eEdge at once
- A maximum of 5,000 messages may be sent from within eEdge per month

- Can I Forward my eEdge Website Domain to Another Website?
 - No. The eEdge website domain is solely tied to the eEdge website.
- Can I Have a Custom Domain Name Instead of _____kwrealty.com?
 - The Pro account with eEdge will allow you to have a custom domain and a custom eEdge email address tied to that domain. Without the pro account, you can only forward a custom domain purchased at a domain registrar to your eEdge website, which leaves the “.kwrealty.com” address in the address bar.
